WHEREAS, Declarant herein caused a Declaration of Covenants, Conditions and Restrictions for Oak Valley to be recorded in Book $\frac{1}{1}$, Page $\frac{1}{1}$, Davie County Registry; and

WHEREAS, Declarant reserved the right to impose additional Restriction Covenants upon individual platted neighborhoods within Oak Valley.

NOW, THEREFORE, Declarant herein imposes the following additional restrictions on those properties contained in Map of Oak Valley, Section 8, Lonetree, as recorded in Plat Book ______, Page _______, Davie County Registry:

- 1. Each residence must utilize water-conservative fixtures and low-flush toilets.
- 2. No residence shall be constructed on any Lot containing less than the following minimum or more than the following maximum square footages of heated living area:

for a 1-story dwelling: a minimum
of 1500 square feet and a maximum of
2000 square feet;

for a 1-1/2 story dwelling: a
minimum of 1700 square feet and a
maximum of 2400 square feet;

for a 2-story dwelling: a minimum
of 1700 square feet and a maximum of
2400 square feet; and

for a split level dwelling: a
minimum of 1500 square feet and a
maximum of 2000 square feet.

The above square footage restrictions do not include area finished in a basement or lower level. The Split Level minimum/maximum

are for the two principal levels of the dwelling. The maximum square footage restriction shall expire 5 years from the date of recordation of this Amendment.
