AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

DAVIE COUNTY

FOR OAK VALLEY

This Amendment to the Declaration of Covenants, Conditions, and Restrictions for Oak Valley, is made this 11th day of May, 19 98 , by Oak Valley Limited Partnership, hereinafter called "Declarant".

WITNESSETH:

WHEREAS, Declarant herein caused a Declaration of Covenants, Conditions and Restrictions for Oak Valley to be recorded in Book 175, Page 143, Davie County Registry; and

WHEREAS, Declarant reserved the right to impose additional Restrictive Covenants upon individual platted neighborhoods within Oak Valley;

NOW THEREFORE, Declarant herein imposes the following additional restrictions on those properties contained on a Map of Oak Valley, Section 11B, Phase 3, Broadmoor as recorded in Plat Book 7, Page 34, Davie County Registry;

- 1. Each residence must utilize water-conservative fixtures and low-flush toilets;
- 2. No residence shall be constructed on any lot containing less than the following minimum square footages of heated living area:

 $\frac{\text{for a 1--story dwelling:}}{\text{square feet;}}$ a minimum of $\frac{1700}{\text{square feet;}}$ square feet;

 $\frac{\text{for a 1 1/2-story dwelling:}}{3000}$ square feet; a minimum of $\frac{2000}{3000}$ square feet;

for a 2-story dwelling: a minimum of $\frac{2000}{100}$ square feet and a maximum of $\frac{3000}{100}$ square feet;

 $\frac{\text{for a split level dwelling:}}{2500}$ square feet and a maximum of $\frac{1700}{2500}$ square feet;

The above square footage restrictions do not include area finished in a basement or lower level. The split level minimum/maximum is for the two principal levels of the dwelling. The maximum square footage restriction shall expire 5 years from the date of recordation of this Amendment.
